### Portable Net System Rental Agreement Terms and Conditions

#### **Responsibilities of the Licensee:**

	1	The undersigned agrees to pay the full rental amount upon signing the Rental Agreement.
	2	Main Contact must be a registered member on the Volleyball Alberta Registration System (VRS), minimum membership: Recreational Player (\$10.25)
	3	The undersigned agrees to be liable for damage and the cost of any repairs or replacement required, outside the normal wear and tear, caused to the equipment by any person during the period that the Licensee had the right to utilize the equipment from the Licensor.
	4	The undersigned agrees to be liable for the cost of any repairs or replacement required
	5	The undersigned agrees to be responsible for any accidents or injuries incurred while using the equipment.
	6	The undersigned agrees that if equipment is late an additional rental fee will be charged. If equipment is lost, stolen, or not returned the undersigned will be charged the cost of replacement.
	7	Any cleaning costs will be the responsibility of the undersigned
	8	The undersigned agrees to pick up and drop off the equipment at the Volleyball Alberta office during the stated office hours.
