Parking is not permitted on any grassy areas at John Fry Park

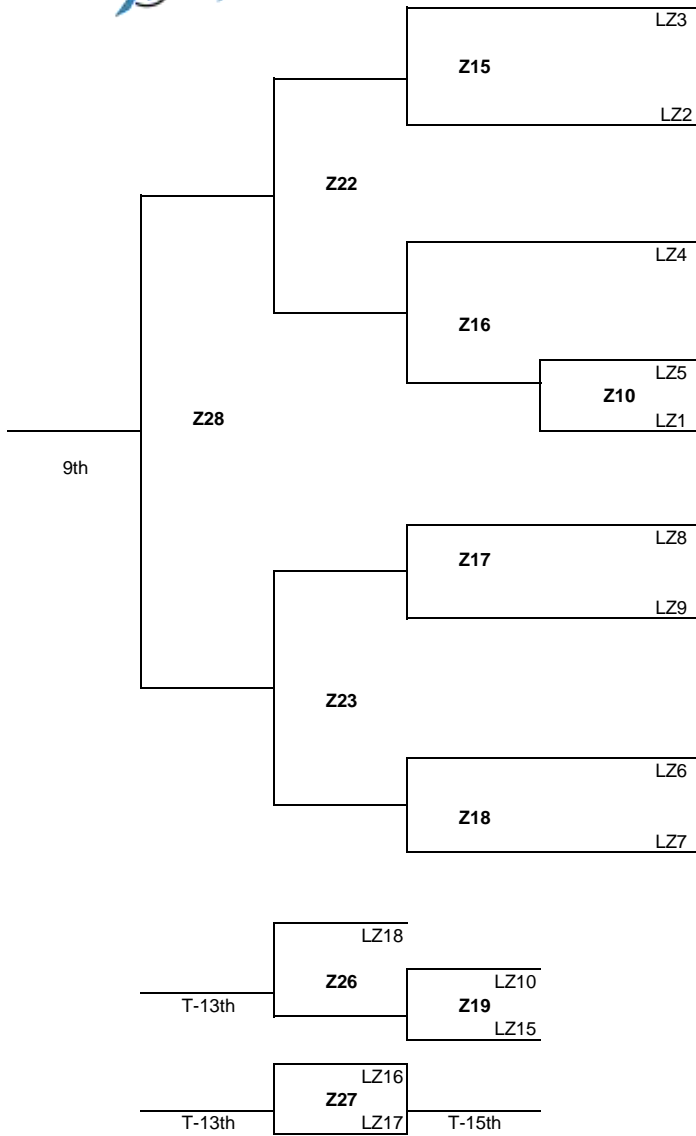
Pool play matches are one set to 25 (switch every 5) Matches are best of 3; two sets to 21 (switch every 7), one set to 15 (switch every 5)
